In pursuance of the authorization made by the Board of Management vide item No. C-15 of its 193rd meeting held on 22.12.2000 and instructions issued vide Registrar's Memo No. Admn. F3/2001/830-929 dated 01.02.2001, the Vice-Chancellor, CCSHAU, Hisar is pleased to order as under:-

- i) That all Laboratory Attendants who are Matriculate are merged / re-designated as Lab. Assistant alongwith post without any change in their pay scales.
- ii) The Laboratory Attendants who are under-matric, will continue to draw their salaries as heretofore against their present posts and will be merged and re-designated as Laboratory Assistant alongwith post as and when they pass Matriculation examination.
- iii) As and when, the post of Lab. Attendant is vacated by Under Matric Laboratory Attendant, due to any reason, the vacated post will be re-designated as Laboratory Assistant.
- iv) The process for filling up the post of Lab. Assistant will be 50% through promotion from amongst Attendants and 50% through direct recruitment.

In exercise of the powers vested in him under Clause (2) of Chapter IX of the Statutes, the Vice-Chancellor is pleased to revise the qualifications for the post of Lab. Assistant as under:

For Promotion

At least Matric pass and willing to do manual work with handling of chemicals and scientific equipments alongwith 7 years experience on the lower post.

For Direct Recruitment

10+2 with Science and willing to do manual work.
