Subject: Raising the age from 58 to 60 years of Government Employees and 62 years in cases of Group D employees.

Sir,

I am directed to invite your attention to rule 3.26(a) of the Punjab Civil Service Rules Volume-I, Part-I, which interalia provides for the age of superannuation of Haryana Government Employees as 58 years except in the case of Judicial Officers, Group IV, Handicapped and Blind Employees in whose case such age has been prescribed as 60 years.

2. The matter has been reconsidered by the State Government and it has been decided that the age of superannuation (retirement) for Haryana Government employees increased from 58 years to 60 years. Similarly, the age of superannuation (retirement) for Class-IV employees increased from 60 years to 62 years.

3. These instructions will come into force immediately. This decision may please be brought to the notice of all concerned for strict compliance.
