**Subject:** Reduction in the age of superannuation from 60 years to 58 years of Government Employees and from 62 years to 60 years in cases of Group D employees.

Sir/Madam,

I am directed to refer to the instructions of the State Government issued vide No. 34/1/2004-4GS1, dated 26/08/2014 in which the age of superannuation for Haryana Government employees was increased from 58 years to 60 years. Similarly, the age of superannuation for Class-IV employees was also increased from 60 years to 62 years, except in the case of Judicial Officers.

2. The matter has been reconsidered by the State Government and it has now been decided that the age of superannuation (retirement) for Haryana Government employees be reduced from 60 years to 58 years except in the case of Judicial Officers. Similarly, the age of superannuation (retirement) for Class-IV employees be reduced from 62 years to 60 years with immediate effect.

3. It is further decided that the employees who had reached to the superannuation age, but could not be retired till date due to enhanced superannuation age as per instructions dated 26/8/2014, will now be retired superannuated on 30<sup>th</sup> November, 2014. This decision may please be brought to the notice of all concerned for strict compliance.
