In pursuance of the decision taken by the Board of Management vide Item No. B-3 of its 239th meeting held on 29.12.2011, the Vice-Chancellor is pleased to amend Conduct Rule (5) (a) & (b) of Chapter XXV of CCSHAU Act & Statutes, as under :

Sub Rule 5 (a) No University employee while in service shall stand as candidate or contest either as an independent candidate or a candidate of any political party or organization, election to the Parliament and the State Legislatures including any local authority. (b) The Board of Management in its 141 st meeting held on 30.12.1991 approved the proposal regarding contesting of elections to Assembly and Parliament by the teachers	(b) Deleted

2. Besides above, the Vice-Chancellor is also pleased to approve adoption of instructions circulated vide C.S. Pb. No. 3936-GII-60/15056 dated 4.5.1960 and vide No. C.S. Hr. No.13/5/96-2GS-III dt. 21.11.1996, in pursuance of above decision of Board of Management , as under:

(i) **Instructions dated 4.5.60** : The question whether or not employees who resign their posts to contest elections should be re-appointed to posts from which they resigned, has been considered by Government. It has been decided that, as a matter of policy, employees who leave Government service in order to take part in elections would not be re-appointed to their original service there after. As ordinary citizens, they will, of course, be eligible for applying for job in the Government, but they will not enjoy continuity of services from their previous employment

(ii) **Instructions dated 21.11.1996**
I am directed to refer to instructions issued vide Pb. Government circular letter No. 3936-G.II-60/15056 dated 4.5.1960 on the subject cited above, conveying the policy decision of the Govt. that employees who leave Government service to take part in elections would not be re-appointed to their original service thereafter. As ordinary citizens they will, however, be eligible for applying for job in the Government, but they will not enjoy continuity of services from their previous employment

It has been observed by the Govt. that these instructions are not being followed strictly. I have been further directed to reiterate that the said instructions should be observed meticulously in letter and spirit in future by all appointing / controlling authorities.
