Subject: Re-designation of Assistant Professor/ equivalent (Selection Grade) as Associate Professor

The Career Advancement Scheme as applicable w.e.f. 6.1.2012 has been adopted in this University with the approval of the Board of Management as per notification issued vide No. Admn. F2/2013/6753-6892 dated 24.12.13.

2. The following provisions have been made under the new Career Advancement Scheme :

- (i) Incumbent Readers and Lecturers (Selection Grade) who have completed three years in the current pay scale of Rs.12000-18300 on 1st January, 2006 shall be placed in Pay Band of Rs.37400-67000 with AGP of Rs.9000 and shall be re-designated as Associate Professor
- (ii) Incumbent Readers and Lecturers (Selection Grade) who had not completed three years in the pay scale of Rs.12000-18300 on 1st January, 2006 shall be placed at the appropriate stage in the Pay Band of Rs.15600-39100 with AGP of Rs.8000 till they complete three years of service in the grade of Lecturer (Selection Grade/ Reader and thereafter shall be placed in the higher Pay Band of Rs.37400-67000 and accordingly re-designated as Associate Professor.
