Last pay drawn minus pension as per rules (Pension+ Pension equivalent to Gratuity) subject to maximum of Rs. 17000/- PM (for those who have passed Departmental Higher Standard Exam. and for retired re-employed Private Secretaries) and Rs. 14000/- PM for those who have not passed Departmental HS Exam.
2	CCS HAU retired non-teaching employees for re-employment against other non-teaching essential vacant posts (other than ministerial cadre) on contract basis.	Last pay drawn minus pension as per rules (pension+ pension equivalent to gratuity) subject to maximum of Rs. 10000/- PM.	Last pay drawn minus pension as per rules (Pension+ Pension equivalent to Gratuity) subject to maximum of Rs. 12000/- PM.
3	CCS HAU retired non-teaching employees Lab. staff for re-employment against the vacant posts of Lab. Attendant on contract basis.	Last pay drawn minus pension as per rules (Pension+ Pension equivalent to Gratuity) subject to maximum of Rs. 8000/- PM.	Last pay drawn minus pension as per rules (Pension+ Pension equivalent to Gratuity) subject to maximum of Rs. 10000/- PM.

2. These revised fixed emoluments will be applicable to the existing non-teaching retired re-employed employees as well. All other terms & conditions will remain unchanged as circulated vide Endst. No. R-2/2010/3710-3860 dated 21.4.2010.
