No. 733-SW(1)-2013.— The Governor of Haryana is pleased to provide reservation to economically backward persons belonging to General Category as per the following:—

- (i) reservation of 10 percent in jobs in Government, Government undertakings and in Local Bodies in direct recruitment to Class III and Class IV posts;
- (ii) reservation of 4 percent in Jobs in Government, Government undertakings and in Local Bodies in direct recruitment to Class I and Class II posts;
- (iii) reservation of 10 percent in admission in Government and Government aided educational institutions, where reservation is provided for in admissions.

2. The criteria for consideration as economically backward will be as under:—

- (i) 'Family' for the purposes of the applicant seeking reservation as 'economically backward' is defined as follows:—
 - (a) Head of Family and his/her spouse;
 - (b) Dependent children and their spouses;
 - (c) Unmarried dependent brothers and sisters.

- (ii) The total annual income of the family of the applicant should not cumulatively exceed Rs.2,50,000/- per annum from all sources including agricultural income.

In case any person in the family, as described in (i) above, is income-tax/wealth tax payee, benefit of reservation shall not be extended.

Applicant or family as described in (i) above should not be in Class-I/Class-II services of Government of India or State Government level or equivalent or hold any equivalent post in any statutory board/corporation/university/society/trust or an equivalent position in any public/private limited company or in any international organization.

Family shall be deemed to be in service as mentioned above when a person in family has superannuated and/or has sought voluntary retirement or has been dismissed/terminated/compulsory retired from such service.

- (v) In case, family as described in (i) above, is engaged in a profession as doctor, lawyer, chartered accountant, income tax consultant, financial or management consultant, engineer, architect, computer specialist, film/TV artist, playwright, author, model, media personnel or holds any elected/appointed office either under the Constitution or in terms of any statute out of which emolument/salary is paid, criteria of income as described in (ii) above shall be applicable.
- (vi) Family, as described above, should not be employed in any Military or para-Military services with Union of India in the rank of 'Second Lieutenant' or above in the Army or any equivalent rank in other forces or para-Military forces.

3. There will be no reservation in promotion in jobs.

4. This reservation for economically backward persons shall be vertical and not horizontal.

5. The person who claims benefit of reservation under other categories (**Scheduled Castes/Backward Classes/Special Backward Classes**) shall not be entitled to reservation in this category.

6. Persons belonging to all castes other than Scheduled Castes/ Backward Classes/Special Backward Classes will be given benefit under this reservation policy. For example, a person belonging to Brahmin, Rajput, Arora, Khatri and Vaishya (Baniya) castes and such other castes which are neither Scheduled Castes nor Backward Class nor Special Backward Class, will be entitled to reservation provided they fulfil the eligibility conditions laid down hitherto.

7. This notification is issued in supersession of this Department's earlier notification No.- 50 SW (1)-2013 dated 23.1.2013.
