2. In pursuance of the orders of the Hon'ble High Court of Punjab & Haryana, Chandigarh passed in CWP No. 17280 of 2014 titled Prem Kumar Verma and others Vs. State of Haryana vide order dated 7.08.2012 quashing the instructions regarding seniority as consequence for promotion under reservation policy to the Scheduled Caste employees which has further been upheld by the Hon'ble Division Bench of Hon'ble Punjab & Haryana High Court in LPA 1352 of 2012, Devender Sachdev and others vide dt. 10.10.2012 conveyed by the State Govt. vide instructions dt. 20.02.2013 and adopted by the University vide Registrar's Endst No. Admn.E-2/2013/1667-1800 dated 02.03.2013 the provisional seniority list of Assistants promoted up to 04.03.2013 has been recast from Sr. No. 353 onwards. The seniority list circulated earlier vide this office Memo under reference from Sr. No. 1 to 352 will remain unchanged.

3. It is, therefore, requested that the provisional seniority list may be got noted from the concerned employees working under your control and obtain acknowledgement in token of having noted the seniority list which may be retained as permanent record in your office.

However, in case any error is detected by any official, the same may be communicated to this office within a fortnight from the date of issue of the said memo. After, completion of prescribed period i.e. a fortnight it will be presumed that there is no objection to any of the employees and the provisional seniority list will be treated as final. It is made clear that after issuance of final seniority list, objections received from any quarter will not be entertained and the responsibility will lie upon your office/department. The provisional seniority list of Assistants is also available on the University Website which can be downloaded.
