**Subject:** 38<sup>th</sup> Amendment in University Calendar Vol. II.

In pursuance of the decision taken by the authority as indicated following additions/amendments are made in the University Calendar Vol. II.

Item No. A-8 in its 456<sup>th</sup> meeting of Academic Council held on 21.03.2015.

Existing Rule 11.6 Page 8	Amended
<p><b>Registration for RAWE/RHWE</b></p> <p>Registration for internship/RHWE shall be allowed only when the student completes the course requirements.</p> <p>(1) For College of Agriculture and College of Home Science if a student is failing in any courses/ courses in 2<sup>nd</sup>, 4<sup>th</sup> &amp; 6<sup>th</sup> semesters or/ and in 7<sup>th</sup> semester, he/she may be allowed registration of RAWE/RHWE in 8<sup>th</sup> semester subject to the condition that but the left over courses should not be more than three and examinations for such courses be arranged within 15 days of registration and result be declared within one month. If the student fails he/she is to be discontinued from RAWE/RHWE. In such cases internship allowance will not be paid.</p>	<p><b>Registration for RAWE/LAHS-491</b></p> <p>Registration for internship/LAHS-491 shall be allowed only when the student completes the course requirements.</p> <p>(1) For College of Agriculture and College of Home Science if a student is failing in any course/ courses in 2<sup>nd</sup>/6<sup>th</sup>, 4<sup>th</sup>/8<sup>th</sup> &amp; 6<sup>th</sup>/10<sup>th</sup> semesters or/ and in 7<sup>th</sup>/11<sup>th</sup> semester of 4-year and 6-year degree programme respectively, he/she may be allowed registration of RAWE/LAHS-491 (Internship/Industrial Attachment) in 8<sup>th</sup> semester of 4-year programme and 12<sup>th</sup> semester of 6-year programme B.Sc. (Hons.) Agriculture/B.Sc. (Hons.) Home Science subject to the condition that but the left over courses should not be more than three non-teaching and examinations for such courses be arranged within 15 days of registration and result be declared within one month. If the student fails he/she is to be discontinued from RAWE / LAHS-491( Internship / Industrial Attachment). In such cases internship allowance will not be paid.</p>

The above amendment will be applicable for the students of B.Sc. (Hons.) Agriculture and B.Sc. (Hons.) Home Science admitted from 2011-12 onwards
