Copy of instructions No. Agri/ 2015/12445 dated 29.6.2015 received from the Additional Chief Secretary to Govt. Haryana, Agriculture Department is forwarded to all Deans/ Directors/Officers of the University-cum- Appointing Authorities and other Controlling Officers, CCS HAU, Hisar for information and taking necessary action. The Vice-Chancellor, CCS HAU, has approved as under:-

- (i) All group-C posts lying vacant or likely to fall vacant due to superannuation up to 31.12.15 (except those group-C posts to be filled through promotion as per line of promotion contained in the Statutes) will be filled by direct recruitment. All the Appointing Authorities and other Controlling Officers will send requisitions in one go of each category of group-C vacant posts separately in the prescribed proforma to the Registrar within a week positively from the date of issue of these instructions. While sending requisitions for advertisement of group-C posts, the prescribed qualifications along-with roster point of posts as per State Govt. reservation policy (including back-log of reservation) and other details will be specified therein.
- (ii) Since the Govt. vide instructions dated 29.6.15 has allowed to fill up all group-C posts lying vacant or falling vacant up to 31.12.15, the approval of the Post Clearance Committee is not required.
- (iii) In view of order dated 27.7.15 passed by the Hon'ble Haryana & Punjab High Court in CWP No. 9132 of 2015 and instructions issued by the Chief Secretary to Govt. Haryana vide No.22/146/2015-1GS-III dated 6.8.2015 adopted in the University, 10% posts meant for Special Backward Classes (SBC) as per roster of Govt. reservation policy will be kept vacant till the final decision of the Hon'ble High Court while filling group-C posts through direct recruitment. All the Appointing Authorities will show vacancies of all group-C posts as per roster point i.e GC/SC/BC/EBPG/SBC/ESM/PWD etc. in the requisition. This office will take further action for keeping 10% posts vacant meant for SBC while floating advertisement.

These instructions may be brought to the notice of all the employees of offices/ departments/Sections/ Units functioning under their administrative control for prompt action.

Sub:- To fill the vacant Group-C posts in CCSHAU, Hisar.

Advisory

State Government has decided that all Group-C posts lying vacant should be filled up on priority basis. Since Vice-Chancellor is the appointing authority in case of the University, you are requested to take further necessary action in the matter. All the Group 'C' vacancies likely to occur due to superannuation upto 31.12.2015 may also be included while advertising the posts. Details of the posts to be filled up giving name of the post (designation), number of total vacancies, unreserved, reserved for SC, BC (A), BC (B), SBC, ESM, PH etc. should be sent to the Government for information. It should be ensured that backlog of reservation is also cleared while filing up these posts. Relaxation in age and educational qualification (up to the extent of 5% marks) should be invariably mentioned in the advertisement as per State reservation policy. A copy of the advertisements so issued should also be sent to the State Government for information and record.
