With an objective of promoting good governance practices in the country, the Department of Administrative Reforms & Public Grievances (DAR&PG) has taken up a number of initiatives which includes production of documentary films, documentation of good governance practices & organizing Conferences, etc. In pursuance of the same, six documentary films have been made during 2014-15 on selected initiatives.

2. The name of the initiatives are as follows: (i) Affidavit free Regime in Punjab, (ii) Control Office Application (COA), (iii) Automated Building Plan Approval System (ABPAS), (iv) SAND - System for Attumanal Neutral Distribution, (v) Conduct of Panchayat Elections in Jammu & Kashmir and (vi) Cervical Cancer Screening, Tamil Nadu.

3. These films showcase various aspects of the success stories including conceptualization, implementation strategies, difficulties encountered and overcome, and impact assessment, towards facilitating effective replication of the best practices elsewhere in the country.

4. Each film is made in Hindi with subtitles in English in three durations: 11-minutes; 8.00 minutes and 3.00 minutes targeting different stakeholders for purpose such as training in National and State Academies, concerned Departments in State Govts, Seminars/Meetings with various Government functionaries up to the level of Gram Panchayats.

5. These films are available on our department's website ([www.darpg.gov.in](http://www.darpg.gov.in)) in downloadable format as well as youtube.

6. I am sure you will find these films useful for adoption, replication and further innovation of these initiatives wherever possible in your state.
