Subject: Grant of reservation in Jobs under Government/Government Undertakings & Local Bodies as well as in admission in Government/Government aided educational/technical/ Professional Institutions.

Sir/ Madam,

I am directed to refer to the subject noted above and to say that vide notification No. 365 SW(1)-2016 dated 31st March, 2016 the Welfare of Scheduled Castes & Backward Classes Department has withdrawn their earlier notification No. 59 SW(1)-2013, dated 24.1.2013 and notification No. 770 SW(1)-2013, dated 10.10.2013 vide which 10% reservation was provided in jobs under Government/Government Undertakings & Local Bodies as well as in admission in Government/Government aided Educational/Technical/Professional institutions to the Special Backward Classes (i.e. Bishnoi, Jat, Jat Sikh, Ror, Tyagi & Mulla Jat/Muslim Jat).

2. Accordingly, now the State Government has decided to delete the following provisions with regard to providing of reservation to Special Backward Classes vide instruction No. 22/10/2013-1GSIII dated 15.7.2014 with immediate effect: -

- i) ✓ In case of direct recruitment in Class I & II posts, column d of the table which provides 5% reservation.
- ii) ✓ In case of direct recruitment in Class III & IV posts column d of the table which provides 10% reservation.
- iii) ✓ In case of admission in Government/Government aided Educational /Technical/Professional institutions para 5 column *d of the table which provides 10% reservation.
- iv) Entire para 4 of these instructions.
- v) Annexure 'C' i.e. list of Special Backward Classes in Haryana State.

The above instructions may please be brought to the notice of all concerned for strict compliance.
