The Vice-Chancellor, CCS HAU, Hisar is pleased to re-employ/extend the re-employment period of the following retired University teachers/scientists who are below 63 years of age as Consultant Faculty at a consolidated fixed salary of Rs. 40,000/- per month in the departments mentioned against each for the period since they report for duty upto 30.06.2018 or till the posts are filled up on regular basis or attain the age of 63 years, whichever is earlier:

2- They will, however, discharge the responsibilities of their post or any other responsibility assigned to them on the following terms and conditions:

1. They will not be regular employee of the University and will not be entitled to claim regular pay scale of post or any other benefits. The University would not be bound to re-employ them on contract after completion of the above term.
2. They would be entitled to casual leave only proportionate to the period for which they are appointed, taking 20 days leave, as the norm for one calendar year.
3. Their contract services will be terminable at any time on 10 days notice in case of financial stringency, unsatisfactory work and conduct. They can also quit on 10 days notice on either side or payment of 10 days consolidated emoluments in lieu thereof.
