Now, it is informed that in view of judgment of Hon'ble Supreme Court of India dated 12.03.2008 in the case of Dev Dutt Vs. Union of India (Civil Appeal No. 7631 of 2002), the State Govt. has decided that every entry in ACR- poor, fair, average, good or very good should be communicated to every officer/official concerned with immediate effect in the supersession of all previous instructions on the issue.
