The Vice-Chancellor, CCS HAU, Hisar is pleased to re-employ Dr. M.K. Rana, Ex. Prof. (Veg. Science) as Consultant Faculty on contract basis on fixed and consolidated emoluments of Rs. 40000/- per month against the vacant post of Assistant Prof. (Veg. Science) in the scheme B.1 N.P. (Agri.) in the Deptt. of Vegetable Science, College of Agriculture, CCS HAU, Hisar for the 1st Semester-2016-17 or till the post is filled up on regular basis whichever is earlier w.e.f. the date he joins his duties. In addition, he will look after the teaching work at COA, Bawal as and when required.

2. However, his services may also be utilized for research/extension activities on the following terms and conditions:

1. He will not be regular employee of the University and will not be entitled to claim regular pay scale of post or any other benefits. The University would not be bound to re-employ him on contract after completion of the above term.
2. He would be entitled to casual leave only proportionate to the period for which he is appointed, taking 20 days leave, as the norm for one calendar year.
3. His contract services will be terminable at any time on 10 days notice in case of financial stringency, unsatisfactory work or conduct. He can also quit on 10 days notice on either side or payment of 10 days consolidated emoluments in lieu thereof.
4. He will be required to produce a Medical Fitness Certificate from Senior Medical Officer, CCSHAU, Hisar, before he is allowed to join.
5. For journeys undertaken in connection with the official work, TA will be admissible as per entitlement of the post against which the re-employment on contract is given.
6. He will be required to sign an agreement bond on non-judicial stamp paper of Rs. 15/- on the prescribed format before he is allowed to join.
7. No benefit of CPF/GPF will be admissible during the tenure of re-employment on contract.
8. He will be required to join the post within a period of 15 days from the date of issue of the order, failing which the offer may be treated as withdrawn.
