Subject: 60th Amendment /addition in University Calendar Vol.-II.

In pursuance of the decision taken by the PC/FC/BOM vide item No. B-21/A-17 in its 77th /255th meeting held on 7.2.2017, the following Gold Medal rules are added as Rule- IV(v) at page 158 Chapter -XVIII in the University Calendar Vol.-II.

"Dr. Savita Singal Gold Medal:

- (a) The Gold Medal will be named as "Dr. Savita Singal Gold Medal".
- (b) This Gold Medal is meant for the best Ph.D.(Home Science) thesis ~~from~~ on rural development in Haryana.
- (c) The students who have worked on these aspects, will be considered for the above gold medal based on the following criteria :
 1. Marks/OGPA 40 marks
 2. Importance of the problem/originality of work and outcome/utility in the context of rural development related to Haryana 30 marks
 3. Publication (s) as first author based on Ph.D. Research (sum total of NAAS score of publication; score of publications without NAAS rating shall be decided by the committee) 15 marks
 4. Presentation and discussion (only for those who have been short listed) 15 marks
- (d) A committee of the five Seniors Professors of COHS constituted by the Vice-Chancellor will evaluate the thesis collectively and award the marks to the students in the meeting chaired by the Dean, PGS. Thereafter, a meeting of Dean, COHS offering Ph.D. including Dean, PGS and Director of Research will be held under the Chairmanship of the worthy Vice-Chancellor for final approval of the award.
- (e) The medal may be given annually at the time of convocation of the university.

- (f) The applications for the award of "Dr. Savita Singal Gold Medal" will be invited by the office of Dean, PGS. The HODs will forward the applications of the interested students alongwith copy of thesis and thesis evaluation report in one lot to the Dean, PGS for taking further action through Dean, COHS.

However, general conditions will remain the same for this Gold Medal as for other gold medals contained in Chapter- XVIII of Univ.Cal.Vol.II."

The above addition/amendment will be applicable from the date of decision of the Board of Management.

The above addition to the University Calendar, Vol.-II may be brought to the notice of all concerned.
