Terms and Conditions:-

1. The appointment will be co-terminus with the project. However, in case, the work and conduct is not found satisfactory, the services can be terminated at any time after giving due opportunity of being heard with one month notice to the concerned employee. If the selected candidate(s) wants to leave, he/she can do so after giving one month notice in writing to the University.
2. The services of the employee will also be liable to be terminated at any point of time, without assigning any reason because of non-release of the grant by the funding agency such as ICAR etc. under whose project/scheme the job(s) is/are advertised.
3. TA/DA will be payable as per rules of the University. However, no TA/DA will be payable for appearing in the interview/joining of duty, if selected.
4. On expiry/completion of the project/term of the project, he/she will stand relieved and the University/Department will not responsible/liable for his/her adjustment in the University on any other post (it is made clear that there is no equivalent post in this University in the same/identical project/schemes).
5. He/She will not be treated as regular employee of the University and would not be entitled to any GPF or other benefits admissible to the regular employee.

6. He/She will be required to produce a medical certificate of fitness from the SMO of the University Hospital at the time of joining.
7. In case of selection, he/she will report for duty within 15 days from the date issued of order of appointment failing which his/her appointment will be treated as cancelled and may be offered to any other candidate.
